7.1 Lengthsman work in February – 90604, 90605, 90602, 90600, 90606, C1073 – general maintenance, unblocking culvert on 90605 as much as possible

7.2 Road and drainage defects to be reported to BB –  
 90604, GR258505 – entrance to stone culvert has collapsed – needs blockage cleared and culvert jetting  
 90604, GR256503 – culvert N side of road W of where parish boundary diverges partially blocked with silt – needs jetting  
 90605, between 90604 and 90602 – ditches blocked with bracken and hedge cuttings – needs ditches digging out  
 90602, 90605 to W boundary – ditches blocked with bracken and hedge cuttings – needs ditches digging out  
 90606, GR 253484 – road surface on inside of bend broken up – needs repair and re-profile of road  
 90606, near Upper Bridge Court – potholes forming – road needs repair  
 90605, GR247489 – culvert under road at Tan House blocked, has been cleared as much as possible – needs pipe jetting

8. Email received from Neighbourhood Planning at HC - Thank you for your email, however to go out on Reg 16 by Monday will not be possible. This is because of the pre-election period we need to wait until after pre-election period-May 8th. Unfortunately there is not enough capacity within the short time frame to complete the proposals maps, amendments to the SEA assessments, Environmental report and HRA assessments in order to proceed to Reg 16. Therefore you will have to wait until May 8th for your Plan to go to Reg 16 consultation.

In the meantime, the Core Strategy Examination is likely to mean 1-2 policies of our NDP need to be altered/removed as the issues they relate to in the Core Strategy have been found to be too restrictive by the Independent Examiner!

11. Notice of Local Elections will go up on 23 March. Nomination papers can be taken to Election Services between 23 March and 4.00 pm on 9 April. Advice is to submit papers well before 9 April if possible.

Papers have to be taken in person or by a representative to Election Services at Shire Hall – cannot be posted, emailed etc.

Nominees have to have a proposer and seconder – these people have to provide their Elector Number from the 2 March Electoral Register which the Clerk has. You can contact the Clerk to get the numbers of your proposer and seconder or you can apply to Election Services for your own copy of the Register.
